




各位会员:

大家好!

2018 年协会进步很大,许可业绩增长显著,各项工作充满亮点!这一年 10 月,协会荣获由世界知识产权组织 (WIPO)和国家版权局共同颁发的国内版权领域最高奖——"中国版权金奖"管理奖,这是对协会 20 余年不懈努力的极大肯定和褒奖。

至2018年,协会许可收入实现连续十年增长,而且当年收入达到人民币3.16亿元,较前一年增长约46%,较2008年增长约756%,再次迈上一个大的台阶。这一许可成绩的实现,主要是由于网络著作权使用费的强劲增长。此外还有一些许可业务也具有重要意义,如:全国范围内九家出版音乐类教材的单位全部与协会签署了教科书法定许可合作协议;广深港高铁列车播放音乐首获协会著作权许可;协会分别与广播、电视版权委员会达成了2016-2020年度广播权付酬增长方案……其间之艰难不必细说,而增长之效果,相信各位会员会在后续的使用费分配中有更多切身感受。

协会的工作,不仅维护了词曲著作权人的合法权益、为使用者合法使用音乐提供了最优解决方案,还增强了著作权保护的社会影响力,在国家知识产权战略部署下与各方配合共同努力推动着全社会的法治进步。

2018年3月15日,协会与日本远藤实歌谣音乐振兴财团在北京共同举办了"中日著作权研讨会",促进了两国著作权保护方面的交流。

2018年下半年,协会担任中共中央宣传部主管的立足全党、面向全社会的学习性公益性互联网平台——"学习强国"学习平台的著作权服务单位,为学习平台合法使用音乐作品提供保障。

2018年9月,协会为推动自身"互联网+"建设,在官网上线了"网上许可系统",为相关使用者办理音乐作品著作权许可提供更大方便。

2018年11月,协会作为著作权服务单位进驻于上海举办的首届中国国际进口博览会,为博览会的成功举办保驾护航。

我们真切感受到,协会的发展推动了社会的法治进步,社会的法治进步也在助力协会的快速发展。协会成绩的取得绝非靠协会一己之力,这既得力于协会会员发展、资料维护、许可合作、法律维权、技术分配、信息宣传等各项业务的 共同发力,更离不开党和国家对知识产权工作的高度重视,离不开国家版权管理部门的正确指导,离不开司法机关对 协会维权工作的有力支持,离不开海外兄弟协会的鼎力相助。当然,全体会员的同心携手,永远是令协会奋勇前行的最强大力量。

为维护作者权益而奋斗的征途,风雨常见,道阻且长,只要协会认准社会发展进步的方向,牢记自己的使命,就一定会走得稳健,走得久远! 2018,我们已经迈过,相信未来更美好。





Dear members,

In year 2018, MCSC's licensing revenue increased significantly and all kinds of work is full of bright spots! In October, MCSC won the Management Award of China Copyright Gold Awards, which is the highest award presented jointly by WIPO and NCAC, and this award means a great recognition for MCSC's tireless effort for more than 20 years.

By the end of 2018, MCSC's licensing revenue reached RMB 316 million yuan to attain consecutive growth for10 years, with an increase of 46% compared with year 2017 and an increase of 756% compared with year 2008. This achievement is primarily due to strong growth of internet & new media revenue. In addition, some other licensing work are also very important, for example, we have signed 9 textbook-publishing units nationwide for statutory licensing; we have signed a copyright licensing agreement for background music usage in the Guangzhou-Shenzhen-Hong Kong Express Rail Line; we have reached a growth plan for royalty payment for broadcasting rights from year 2016 to 2020 with the Television Copyright Committee and the Radio Copyright Committee separately..... We don't want to talk about difficulties in work, but we believe that our members will may feel the growth of royalty distribution in the near future.

MCSC's work not only protects legitimate rights & interests of copyright holders, provides optimal solutions for music users to use music legally, but also enhances the influence of copyright protection in society, and works together with all parties to promote the progress of law & order in the whole society under the National Intellectual Property Strategy.

On March 15, 2018, MCSC jointly organized the "Sino-Japanese Copyright Seminar" with Minoru Endo Music Foundation to accelerate the exchange in the field of copyright protection between China and Japan.

In the second half of 2018, MCSC was appointed as one of copyright service units for the "Learning Power" platform by the Publicity Department of the Communist Party of China (CPC) Central Committee, which is an internet learning platform for public welfare and is based on service for our Party and facing the whole society, to guarantee legal usage of music in the learning platform.

In order to promote the "internet plus", MCSC launched the "Music Works Online Licensing System" and the system was opened in September 2018 on its official website to provide music users with licensing service.

In November 2018, as one of copyright service units, MCSC entered and stationed in the first China

We have really felt that MCSC's development promoted the progress of the law & order in our society, and in return the progress of the law & order in our society also contributed to the rapid development of MCSC. The achievements of MCSC are not only dependent on its own efforts, which include the development of membership, documentation, licensing, legal actions, distribution & technology, information propaganda and other works, but also more rely on great importance by our Party and our country to the intellectual property work, and cannot be separated from the guidance of the National Copyright Administration, the strong support from the judicial organs, and the great help of our sister societies overseas. Of course, the concerted efforts of all of our members will always be the most powerful force for MCSC's development.

Although the way to safeguard copyright holders' rights & interests is difficult and long, we believe that we will certainly go steadily and long if we would find our society's direction of development & progress and remember our mission. By now, we have passed the year 2018 and we believe that the future will be better.














2018 年初,协会受山东省济宁市中级人民法院的协助请求,就其正在审理的张永清与高永安、潘龙江侵犯著作权纠纷一案, 对涉案的三首歌曲曲谱相互之间全部或部分是否构成实质性相似进行技术鉴定。协会与多位符合要求的知名会员联络后,最终确 定由中央音乐学院作曲系郝维亚教授、中国音乐学院作曲系王宁教授、中央民族大学音乐学院张朝教授担任此项工作的鉴定专家。 经过各位专家独立、细致的工作,做出了专业性的判断,分别出具鉴定意见书,为案件的判决提供了专业技术保障,圆满地完成

此外,协会还为北京、沧州、无锡、张家港等地的版权局、扫黄打非办或文化市场执法机构就当地违法侵权事项所涉歌曲进 行了鉴定核查, 出具了相关鉴定结论的法律文书等。

At the beginning of 2018, MCSC was requested by Jining City Intermediate People's Court in Shandong Province, to assist in the case of copyright infringement dispute between Zhang Yongqing and Gao Yongan, Pan Longjiang for the technical identification of whether all or part of the three songs involved constituted substantial similarity with each other. After liaising with a number of well-known members who met the requirements, MCSC finally decided to invite Professor Hao Weiya of the composition department of the Central Conservatory of Music, Professor Wang Ning of the composition department of the China Conservatory of Music and Professor Zhang Chao of music school of Minzu University of China to serve as expert team in this work. After the independent and meticulous work by each expert, finally the appraisal opinions were issued separately and the professional technical guarantee was provided for the judgment of the case to complete the work required by the court successfully.

In addition, MCSC also carried out the verification of violated musical works and issued relevant legal documents of identification conclusion for the Copyright Administration Bureaus, anti-pornography & illegal publications offices and cultural market law enforcement agencies of Beijing, Cangzhou, Wuxi, Zhangjiagang and other cities.

在京举办"中日著作权研讨会"

The "Sino-Japanese Copyright Seminar" in Beijing

3月15日,由中国音乐著作权协会与日本远藤实歌谣 音乐振兴财团共同主办的 2018 年度 "中日著作权研讨会" 在北京召开。研讨会主要围绕"互联网音乐的现状与问题" 展开,通过介绍中日两国互联网音乐的发展状况与数字音 乐版权保护的具体实务,探讨数字时代下网络音乐版权保 护的应对方案。

On March 15, the "Sino-Japanese Copyright Seminar", jointly organized by Minoru Endo Music Foundation and MCSC, was held in Beijing. This seminar mainly focused on "the current situation and problems of Internet Music". Through introducing the development of Internet music in Japan and China and the specific practice of digital music copyright protection, our two parties shared views, exchanged experiences with each other, and discussed the countermeasures of internet music copyright protection in the digital age.



音乐作品广播权付酬标准实现增长



Increase in the standard of remuneration for broadcasting rights

协会与中国广播电视协会电视版权委员会、广播版权委员会本着"低起点、可操作、着眼长远、逐渐递增、互利双赢的理念" 创立了适合中国国情的广播权许可付费模式,但是,该模式的著作权使用费多年以来并未实现增长,而现行付酬标准与《付酬办法》 的较大差距,始终是各方权利人,国内、国际有关组织关注的焦点,这不仅影响到我国广电行业音乐版权保护水平,也影响到我 国音乐版权保护整体水平。

协会自 2012 年起,即开始同电视版权委员会、广播版权委员会就许可使用费增长问题进行磋商,经过 6 年艰苦的谈判,终于 在 2018 年 4 月、9 月分别同电视、广播两版权委员会达成了《合作备忘录》,在一定程度上实现了我国广电行业整体音乐著作权

Based on low starting point and a long-term view, a practical and gradual increased standard tariff for royalty payment of broadcasting rights have been set between the Radio Copyright Committee & Television Copyright Committee of China Radio & Television Association and MCSC for years. However, until now this payment standard for broadcasting rights have not increased over the years in fact, and there exists a large gap between our current standard of payment and the «Provisional Measure for Payment of Royalties for Broadcasting of Sound Recordings by Radio and Television Stations» issued by our State Council in 2009. Low royalty payment for broadcasting rights has always been the focus of all of right holders, domestic and international organizations concerned, which not only affects the level of music copyright protection in China's radio and television industry, but also affects the overall level of music copyright protection in China.

Since year 2012, MCSC began negotiating with the Television Copyright Committee and the Radio Copyright Committee for increasing royalty standard. After six years' difficult negotiations, MCSC finally reached the Memorandum of Cooperation with the Television Copyright Committee and the Radio Copyright Committee in April and September of 2018 separately to realize the whole increase on music royalty payment in radio & television industry in China.

教科书法定许可



Statutory licensing for works used in Textbooks

2018 年 5 月,辽海出版社向协会办理了教科书使用音乐的著作权许可。至此,自 2013 年启动教科书付酬工作以来,全国范围内九家出版教材的单位均与协会签署了合作协议。

In May 2018, MCSC issued a statutory license to Liaohai Publishing House for musical works used in textbooks. So far, since the start of our statutory licensing for textbooks in 2013, we have signed 9 textbook-publishing units nationwide.

航空公司(航班用音乐)全行业获得协会著作权许可

截止到 2018 年 6 月,经过多年的不懈努力,协会已与中国大陆地区的 17 家航空公司签署了《音乐著作权许可使用协议》,这其中包括全部中型以上航空公司,获得音乐著作权许可的客机数量约占国内飞机总量的 98%,基本实现了行业全覆盖。签约公司包括:中国国际航空、南方航空、海南航空、东方航空、厦门航空、上海航空、深圳航空、四川航空、山东航空、奥凯航空、东海航空、瑞丽航空、贵州多彩航空、华夏航空、江西航空、河北航空公司、上海吉祥航空等。(注 小型航空公司的航班、短途航班一般不用音乐)

As of June 2018, after years of effors MCSC has signed with 17 airlines on the music copyright license agreement in mainland China in which all medium-sized airlines are included, and the number of licensed airlines accounts for about 98 % of the total number of aircraft in our country, basically covering the whole industry. The signed companies include: Air China, China Southern, Hainan Airlines, China Eastern, Xiamen Air, Shanghai Airlines, Shenzhen Airlines, Sichuan Airlines, Shandong Airlines, Okay Airways Company Limited, Shenzhen Donghai Airlines, Ruili Airlines, Guizhou Colorful Airlines, China Express, Jiangxi Air, Hebei Airlines, Juneyao Airlines and so on. (note: small airlines, short-haul flights don't use music usually)

Renewal of cooperation with Tencent Music

腾讯音乐旗下包括QQ音乐、酷狗音乐、酷我音乐等多个音乐平台,其产品还涉及全民K歌,酷狗直播等各类应用,是市场上最大、最具影响力的音乐网络平台。2017年,根据网络音乐市场的最新变化,协会决定与腾讯音乐重新协商此前达成的许可协议内容。 经过近1年的磋商与谈判,双方最终成功续展合作协议,实现了许可使用费的大幅增长。

Renewal of cooperation reached with Tencent Music includes QQ Music, KuGou Music, KuWo Music and many other music platforms, as well as APPs such as KuGou Live broadcast and so on. Tencen Music is the largest and the most influential online music giant in Chinese market. In 2017, with the changes in the online music market, MCSC decided to renegotiate the content of its previous license agreement with Tencent Music. After nearly a year of consultations and negotiations, our two sides finally renewed the cooperation agreement successfully, resulting in a substantial increase in royalty payment.

Publishing the books of "Q & A -- the Compilation of MCSC's Knowledges" and "Review & Prospect of Broadcasting rights Work"

8 月,《你问我答——中国音乐著作权协会知识汇编》(《知识汇编》)、《广播权工作回顾与展望》制作完成,并向业内相关人士、广大会员寄送。

《知识汇编》共收集问题 273 个,以你问我答的形式,从协会整体、会员发展、作品资料与管理、许可与诉讼和使用费分配等方面全面介绍了协会开展集体管理工作的具体内容;《广播权工作回顾与展望》基于广播权许可业务的需求,整体回顾了协会广播权工作在立法、许可、维权等不同阶段的情况,反映词曲作者和协会在其中付出的巨大努力,以及让协会会员、社会各界更多了解协会,并监督、支持协会更好地向前推进包括广播权在内的各项工作。



The two books of "Q & A -- the Compilation of MCSC's Knowledges" and "Review & Prospect of Broadcasting rights Work", which were compiled by MCSC, were completed in August and sent to its members and people of industry insides in the same month.

In "Q & A -- the Compilation of MCSC's Knowledges" the total of 273 questions was collected and compiled in the form of Q & A to introduce MCSC's collective management work in the field of our overall work, membership development, documentation & management, licensing & litigation and royalty distribution; based on the demand of broadcasting rights licensing, the book of "Review & Prospect of Broadcasting rights Work" reviewed MCSC's work for broadcasting rights at different stages of legislation, licensing & safeguarding, reflected great efforts by composers, lyricists, songwriters and MCSC itself, and also let the members, social sectors know more about MCSC and supervise and support MCSC's all of work including broadcasting licensing.

正式开通"音乐作品网上许可系统"



Opening the "Music Works Online Licensing System"

为了更方便广大使用者办理音乐著作权许可使用申请,协会官方网站于 2018 年 9 月正式开通了"音乐作品网上许可系统"。 通过该系统,使用者只需在线填写、提交相应的信息,即可完成使用申请工作。

目前已开通的功能主要针对复制权类、现场表演权类使用者的音乐许可使用申请,如:音乐会、演唱会使用音乐;教科书法定许可、音乐图书出版、乐谱出版、制作 CD、VCD、DVD 等录音 \ 录像制品、广告 \ 宣传片类使用音乐、影视作品类使用音乐及其他工业制品类使用音乐等。

In order to facilitate the majority of users to apply for music copyright license more conveniently, MCSC's "Music Works Online Licensing System" was officially opened in September 2018. Through this system, users can complete licensing application only by filling in and submitting the corresponding information online.

At present, the functions have been opened mainly for categories of licensing for mechanical reproduction rights and live performance rights such as music usage in concert, textbook, music book, music score, production of audio & video products (CD, VCD, DVD), advertising, film & television, etc.

With the Guangzhou-Shenzhen-Hong Kong Express Rail Link officially opened on Sept 23, MCSC and the Mass Transit Company Limited (MTRCL) reached the copyright licensing agreement for background music usage. This is the first time for MCSC to grant music copyright licensing for the entire railway line of passenger trains.
